  - III. Tenderer should also file the details regarding the experience of providing services in the field for the last three years.
  - IV. The Tenderer shall quote the rate inclusive all taxes. The amount should be written both in numbers as well as in words.
  - V. No extra charges will be acceptable.
  - VI. Payment will be made on successfully Completion of work subject to availability of fund and no advance payment shall be made in any condition.
  - VII. The work is to be completed within 20 days from work order.
