**Item** : To discuss the matter relating to the strengthening of monitoring mechanism for expeditious investigation and trial of cases.

**Resolution:** The District and Sessions Judge, Sivasagar, at the outset, has welcomed all the members of the committee. Initiating the discussions, the District and Sessions Judge, Sivasagar has informed the Supdt. of Police, Sivasagar present in the meeting, that proper training may be imparted to the I.O.s regarding the provisions of the new Criminal Laws to be implemented from the month of July and that if required, modules of training may be prepared in consultation with CJM and Secretary, DLSA, Sivasagar.

The District and Sessions Judge, Sivasagar has also emphasised on identification of the cases where reports furnished by the I.O.s are not convincing and in this regard, she has requested the CJM, Sivasagar to ask the respective Magistrates for the identification of the same.



Continuing the discussion, the CJM, Sivasagar, present in the meeting, has expressed concern regarding service of summons in proper time, especially to the I.O.s posted in Barak valley and South Salmara Districts. The District and Sessions Judge, Sivasagar, in this regard, has asked the CJM, Sivasagar to prepare a list of all those cases, so that matter can be followed up vigorously with the help of Supdt. Of Police, Sivasagar.

The Supdt. Of Police, Sivasagar has requested the District and Sessions Judge, Sivasagar to instruct the P.P.s to mention the phone numbers in every summons without fail.

Concluding the discussions, the District and Sessions Judge, Sivasagar has asked the District Jail Authorities, Sivasagar present in the meeting, to ensure the physical presence of the UTPs in certain cases such as 313 Cr. P.C., argument stage etc. without fail.
