**Item** : To discuss the matter relating to the strengthening of monitoring mechanism for expeditious investigation and trial of cases.


**Resolution:** The District and Sessions Judge, Sivasagar, at the outset, has welcomed all the members of the committee. Initiating the discussions, the District and Sessions Judge, Sivasagar has asked the Addl. Supdt. Of Police (HQ), Sivasagar present in the meeting, to sensitize the I.O.s to conduct the investigations in a proper and professional manner by strictly adhering to the provisions and procedures laid down in the NDPS Act.

The District and Sessions Judge, Sivasagar has provided a list of cases pending for service of summons in the Special POCSO Court, Sivasagar to the Addl. SP (HQ), Sivasagar and has requested to do the needful regarding the same at the earliest. The CJM, Sivasagar has also provided a list of 29 (twenty nine) nos. of cases to the Addl. SP (HQ), Sivasagar which are pending at I.O. stage in various Magisterial Courts under the District Judiciary of Sivasagar.

Continuing the discussion, the District and Sessions Judge, Sivasagar has asked the Addl. SP (HQ), Sivasagar to instruct the I.O.s to cautiously deal with the POCSO cases since there are instances evident wherein it has been shown that the birth certificate is reflected in the seizure list, but the same could not be found in records. The District and Sessions Judge, Sivasagar has also asked the Addl. SP (HQ), Sivasagar to instruct the I.O.s to ensure that the respective MRs to be produced for the respective cases along with charge-sheet.


