The trainees shall sit in the Court with the Officer with whom they are attached at least one half of the day and during the other half they shall do the following works:-

- d. Examining the case record.
- e. Examining different registers, statements etc.
- f. Preparing Field Training Diary to be maintained by the respective trainees.

The trainees shall attend at least 10 (ten) **bail matter** hearings and 5 (five) injunction matter hearings.

While preparing the **Field Training Diary**, the trainees shall maintain a record of how they have spent each and every day in the Court; they shall also mention what they have noticed during their observation in the court and sections of the Office of the Court. They shall also mention about their observations on the case records, which they have examined. The Officer with whom the Trainees are attached is to certify the Field Training Diary daily and submit the same before the undersigned every week for certification.

The trainee Officers are directed to accompany the Chief Judicial Magistrate during their Jail inspection.

The trainee Officers are directed to report to the Ld. Chief Judicial Magistrate, Sivasagar, as their **co-ordinating Officer** for the concerned period.
