

**OFFICE OF THE DISTRICT JUDGE, SOUTH 24-PARGANAS AT ALIPORE**

Order No. 51 - M, dated, Alipore, the 27th day of March, 2024.

In terms of Government of West Bengal, Judicial Department Notification No. 5144-J and 5145-J both dated 20/07/2009, stenographers of Courts are classified into 3 (three) categories namely Stenographer Grade I (Grade A), Stenographer Grade II (Grade B) and Stenographer Grade III (Grade C) in respect of three clusters.

Consequent upon the above, the strength of the Stenographers in 3 (three) categories and their pay level as on 05/07/2021 prior to date of effect of West Bengal District Court Rules, 2015 are detailed as follows :

- i) Stenographer Grade I (Grade A) : 27 [ Pay level -15 (Rs. 42600/- to Rs. 109800/-) in terms of W.B ROPA Rules 2019]
- ii) Stenographer Grade II (Grade B) : 23 [ Pay level -13 (Rs. 37100/- to Rs. 95500/-) in terms of W.B ROPA Rules 2019]
- iii) Stenographer Grade III (Grade C) : 52 [ Pay level -10 (Rs. 32100/- to Rs. 82900/-) in terms of W.B ROPA Rules 2019]

Perused the reports dated 21/03/2024 of the Committee constituted for Gradation and Promotion to the different cadres of the employees of the Judgeship of South 24 – Parganas. It reveals that lastly vide order no. 257-M dated 03/12/2022, promotions were given against the vacancies arisen up to 31/12/2019 in both Stenographer Grade-I and Stenographer Grade-II.

Thereafter due to retirement, 4 (four) vacancies in Stenographer Grade-I have arisen during the period since 01/01/2020 up to 05/07/2021.

Similarly, there are 5 (five) vacancies in Stenographer Grade-II due to elevation of 4 (four) Grade-II Stenographers to Grade-I and pre mature death of 1 (one) Grade-II Stenographer namely Sri Surajit Barman.(died on 03/05/2021)

It transpires from both the 50 point Rosters that previously promotion were allowed up to 24<sup>th</sup> vacancy position in Grade-I and 47<sup>th</sup> vacancy position in Grade-II respectively.

The report of the Committee is considered and the proposal for promotion of the eligible employees is accepted.

Accordingly, this promotion order is hereby issued on the basis of the Final Gradation List of the Stenographer as it stood on 01/01/2023 and in accordance with the 50 Point Roster Register as per Rule.

Hence the following eligible employees holding the post of Stenographer Grade-II (Grade-B) in order of seniority are being promoted to the post of Stenographer Grade-I (Grade-A) in the Pay Band No. 4 (Rs. 9000/- to Rs. 40500/-) with Grade Pay Rs. 4800/- in terms of W.B.S ROPA Rules, 2009 which has subsequently been revised as Pay Level 15 (Rs. 42600/- to Rs. 109800/- ) in terms of W.B.S ROPA Rules, 2019 w e f the date mentioned against the name of each of the promotees.


