

**OFFICE OF THE DISTRICT JUDGE, SOUTH 24-PARGANAS AT ALIPORE**

Order No. 54 -M, dated, Alipore, the 4th day April, 2024.

Perused the reports/ recommendations of the Committee for Promotion, Preparation and Finalization of Gradation List of Staff of the Judgeship of South 24 Parganas, forwarded by letter being No. 60 – Con ADJ, 8th Court, Alipore dated 08/02/2024.

It appears from the Final report dated 24/01/2024 along with the report dated 05/10/2023 that the earlier promotion Order being No. 87-M dated 27/03/2017 was found erroneous on the basis of anomalies pointed out during hearing of the objections filed by Typists/ Copyists. There were certain issues regarding seniority and reservation on the basis of 50 point Roster, which need to be rectified.

Meanwhile, few posts of Typist/Copyist in Supervisory Grade and Typist Copyist Grade-I falls vacant due to retirement of the employees in both the categories.

Certain disputes/ambiguities have cropped up regarding promotional policy and constitution of Service while implementing West Bengal District Court Rules, 2015, which came into force since 06/07/2021. The issues have not yet been resolved and are under consideration of The Hon'ble Court.

Therefore, the posts which falls vacant till 05/07/2021 are taken into consideration while allowing promotion from Basic Grade to Grade-I and from Grade-I to Supervisory Grade in accordance with the FD Memo No. 1583-F(P) dated 21/02/2012.

In the last published promotion order vide Order No. 20-M dated 13/01/2015 prior to issuance of Order No. 87-M dated 27/03/2017, promotions were allowed against the vacancies arisen till 31/07/2014 in Supervisory Grade and till 01/01/2014 in Grade-I. From the Office record and relevant registers, it transpires that 14 (fourteen) vacancies arisen since 01/08/14 to 05/07/2021 in Supervisory Grade, out of which 6 vacancies were filled up vide Order No. 87-M dated 27/03/2017. Whereas, 26 (Twenty-Six) vacancies arisen in Grade-I since 01/02/2014 till 05/07/2021, out of which 16 vacancies were filled up vide Order No. 87-M dated 27/03/2017.

In such circumstances, considering the Final Gradation List as it stood on 01/01/2017 and in view of the recommendation of the Committee, the following 8 Typists/ Copyists Grade-I are found suitable in terms of OPR and are promoted to the Supervisor Grade listed along with other 6 already promoted Supervisor with revised effect date and revised Roster position in accordance with 50 point Roster.
