The Judicial Magistrate on duty shall take up the first Remand Application on expiry of statutory period as provided under section 167(2) of the Cr. P.C on the date shown against their names in the court room of the Ld. Chief Judicial Magistrate, South 24 Parganas, at 2.00 p.m.

The Magistrates in stand by duties will hold themselves in readiness and move in the court on call to take up the files immediately. The Magistrate if he is prevented by the circumstances beyond control from taking up the Remand File at the fixed date and time, shall intimate to the officer-stand by for taking up the Remand File. This Remand Roster is prepared in consultation and consent of all the Ld Judicial Magistrates present in accordance with Rule and Act as per C.R.O. and the same stands approved. It be also noted here that if there be any holiday declared in the relevant month which is not noted in the roster schedule, then the officer holding the holiday reamand file on the immediate preceeding holiday would hold the holiday remand file on the said holiday which might be so declared.

The same roster is to be followed apropos the stand by officer and the staff member.

This order is made to avoid complication of making fresh roster within the month if any holiday so declared. No Adjournment matter shall be put up before the Ld. Magistrate during Roster file.
