In the light of Hon'ble high Court of Jammu and Kashmir and Ladakh communication No.28751/Infst. Dated:18.11.2017 with regard to permission to cut Eucalyptus tree standing and dry Eucalyptus tree lying within the residential premises of Principal District & Sessions Judge, Poonch and Munsiff, District Mobile Magistrate, Traffic Poonch. This office vide communication No.451/PDSJP Dated:12/10/2023 directed the Divisional Forest Officer(DFO) Poonch Forest Division, for deputing a special team of Forest Officials to visit the premises of the undersigned and Munsiff, District Mobile magistrate traffic Poonch and identify such trees which poses serious threat to the life and property of the Judicial Officers and the persons residing adjacent to the area and also prepare assessment value of such trees and submit the report to this office.

The DFO Poonch in reply to this office communication number submitted a detailed report about the trees lying within the residential premises of the undersigned and Munsiff, District Mobile Magistrate, Traffic Poonch alongwith assessment values of the trees. From the perusal of the communication received from the DFO Poonch, it reveals that there are 46 trees lying in the premises of the undersigned and Munsiff, District Mobile Magistrate Poonch the detail of which has been mentioned by the DFO in his letter No.DFO/PFD/4104 Dated:7.11.2023 alongwith the detailed report submitted by Forest Range Officer Haveli Poonch, Block Officer Poonch and Beat Guard Poonch. The value assessed by the Forest Officials of the above referred trees has been given as Rs.3,43,570/-.

Therefore, in the light of the permission of the Hon'ble High Court and detailed report received from the Forest Department about the cost of the trees, the following Committee is constituted for proper disposal/auction of trees by inviting applications from the interested persons of the above rated costs.


