
### आदेश

[dcbulandshahr@gmail.com](mailto:dcbulandshahr@gmail.com) पर प्रेषित करने हेतु सूचना सम्बन्धित के मध्य परिचालित करें। इस अनुक्रम में समस्त पीठासीन अधिकारीगण सुनिश्चित करें कि वीडियो कान्फ्रेन्सिंग से सम्बन्धित समस्त प्रक्रिया अधोहस्ताक्षरी के आदेश संख्या 212 / 2024 दिनांकित 19.11.2024 के अनुसार सम्बन्धित न्यायालय के प्रशिक्षित कर्मचारी के द्वारा सम्पन्न किया जाये।
