Terms & Conditions

2- The terms and conditions of service shall be governed as per provision of G.O. Nos. 197/Saat-nyay-7-2008-47/2002, dated 26-03-2008; 827/Saat-nyay-7-2014-47/2002, dated 18-11-2014 and 02/2018/661/saat-nyaya-7-2018-47/2002, dated 30-01-2018 and the eligibility criteria under section 22 B (2) (a) of the Legal Services Authorities Act, 1987, which is as follows:-

- (i) A person who is, or has been a District Judge or Additional District Judge or has held judicial officer higher in rank than that of District Judge shall be eligible for the post of Chairman of the Permanent Lok Adalat.
- (ii) The applicant should not have retired before two years from the date of advertisement; similarly, the currently working (Judicial Officers) applicants may apply only if they will be retiring before next 03 months from the date of advertisement.
- (iii) The Total period of office shall not exceed 05 years or the attainment of the age of 65, whichever is earlier.
- (iv) The selected Applicant shall not be entitled to the extension of time to join at the place of offered posting on the ground of his term of Judicial Office still subsisting. He/She should have resigned from his Judicial Office on or before the date of offer of appointment.
- (v) Judicial Officers against whom departmental and/or vigilance enquiry is pending or who have been punished may be excluded from the zone of consideration.
- (vi) The Selection to the post of Chairman shall be on merit based interview, service records, confidential remarks, his/her character, general conduct and reputation. The Selection Committee shall adjudge the suitability and /or fitness of the candidate on the basis of interview. The Selection Committee is also authorized to decide the suitability of the candidate on the basis of scrutiny and/or evaluation of all the documents.
- (vii) The terms and conditions of the service of Chairpersons of the Permanent Lok Adalats (PLA) including the resignation and removal of such persons shall be governed by the terms and conditions outlined in Notification F.No.

A-60011(3)/2001-Admin. III (LA) dated 2nd January, 2003 of the ministry of Law and Justice, Government of India and other relevant rules applicable to the government servants enforce.

- (viii) The Chairperson before appointment shall have to furnish an undertaking that does not and will not have such financial or other interest as is likely to affect prejudicially his functions as such Chairperson.
- (ix) The Chairperson may be transferred from one district to other district on administrative ground/ exigency and/or public interest with the approval of the Executive Chairman, UPSLSA.
- (x) The Chairpersons shall be entitled to receive the salary etc. as per G.O. Nos.: 197/Saat-nyay-7-2008-47/2002, dated 26-03-2008; 827/Saat-nyay-7-2014-47/2002, dated 18-11-2014 and 02/2018/661/saat-nyaya-7-2018-47/2002, dated 30-01-2018 which provides " अन्तिरम आहरित वेतन में से पेंशन की धनराशि को घटाते हुये वेतन तथा उस पर राज्य सरकार द्वारा समय-समय पर अनुमन्य महंगाई भत्ता "।
