Therefore applications are invited for appointment for the posts of Special Metropolitan Magistrate on consolidated Honorarium of Rs.15,000/- per month. The age, qualifications and experience required are as under.

The eligible persons according to the qualifications given below shall send their applications along with attestation forms in prescribed proforma in duplicate together with their BIODATA to this office by 04 - 03-2024.

#### 1. **QUALIFICATIONS**:

A person

i) Who has held any post in Higher Judicial Service or State Judicial Service and retired or resigned, or

ii) who has held a post in the Judicial Ministerial Service not below the rank of Head Clerk of District Munsif's Court and has a Law Degree.

Who has held a post of Section Officer and above in the High Court Service and has a Law Degree, or

iv) A non-practicing certificate must be enclosed.

v) A non-practicing advocate with practice at the Bar of not less than five years and who is above 45 years of age; or

vi) Any retired Gazetted Officer possessing Law Degree or who has passed the Criminal Judicial Test (full test consisting of the Indian Penal Code and the Code of Criminal procedure) conducted by the Telangana/Andhra Pradesh Public Service Commission and who has exercised Magisterial powers during his tenure of service for not less than three years;

And who has at least one year to complete 65 years of age at the date fixed by the Court in the year for recruitment, shall alone be eligible.

# II <u>DISQUALIFICATIONS</u>:

A person

1) Who is a practicing Advocate or

2) Who is a Member of any State or local authority or

3) 4)

Who is member of the State Legislature or of the Parliament; or A person who having held an officer under the State or the Union Government or any local Authority has been dismissed or removed or compulsorily retired from service or subject to any other major penalty for misconduct; or 5)

A person who has been convicted and sentenced by a Court for an offence

A person of unsound mind or who is deaf or mute or blind or suffering from 6) 7)

A person adjudicated as an insolvent or an un-discharged insolvent; or

A contractor or a businessman or one interested in a subsisting contract or any 8) work being done for Central or State Government or a local authority within whose limit the Special Magistrate has to discharge his duties shall not be eligible.

# IV REVOCATION OF POWERS OF SPECIAL MAGISTRATES:

- On appointment and while in service a Special Magistrate of II Class or Special 1) Magistrate of any other category may be removed without being called upon to show cause if he failed to attend three consecutive sittings of the court
- Powers conferred by the Court on Special Judicial Magistrates of II Class or 2) Special Magistrate of any other category shall automatically stand withdrawn on his attaining the age of 65 years.
