In exercise of the powers conferred by Sub-section (3) of Section (19) of Criminal Procedure Code, and with reference to the above subject and reference cited, territorial limits are distributed among the newly sanctioned [08] Junior Civil Judges - Cum - Judicial Magistrate of First Class Courts, specially designated to try cases filed under section 138 Negotiable Instruments Act, in the Unit of Hon'ble Metropolitan Sessions Judge, Hyderabad, as shown below. The following Courts are also empowered to try cases filed under Indian Penal Code and other Acts as per Schedule-I and Schedule-II, respectively, of Criminal Procedure Code 1972, in their territorial jurisdictions.
