The **I Additional Sessions Judge, Hyderabad** hereby makes the following orders in respect of the arrangements for recording Dying Declarations in **Osmania General Hospital and other Hospitals at Hyderabad and Gandhi Hospital and other Hospitals at Secunderabad, w.e.f. 01-05-2025.**

During the period specified in Col.No.2 the Additional Chief Judicial Magistrates and Judicial Magistrate of First class specified in Col.No.3 are hereby nominated for recording Dying Declarations in **Osmania General Hospital and other Hospitals at Hyderabad irrespective of the Zones of Hyderabad** and the Judicial Officers specified in Col.No.4 shall be incharge in case of the absence of the Officers indicated in Col.No.3 of the table given below:

The Additional Chief Judicial Magistrates and Judicial Magistrate of First class mentioned in Col.No.5 are hereby nominated for recording Dying Declarations in **Gandhi Hospital and other Hospitals at Secunderabad** irrespective of the Zones of Secunderabad during the period specified in Col. No.2 and the Officers indicated in Col.No.6 shall be incharge in case of the absence of the Officers indicated in Col.No.5 of the table given below:


All the Additional Chief Judicial Magistrates and Judicial Magistrate of First class are required to inform this office their residential addresses and telephone numbers. They are hereby directed not to apply for any kind of leave during the period in which they are nominated to record the Dying Declarations and in case of unavoidable circumstances only, they may apply for leave duly explaining the circumstances in detail in writing atleast (3) days in advance by obtaining the consent of the other presiding officer who is willing to attend the duty of recording Dying Declarations and shall not leave the Head Quarters before the leave is granted. These Orders shall come into force with effect from **01-05-2025.** The receipt of above proceedings shall be acknowledged.
