The Director General of Police, Telangana, Hyderabad in the letter read above has reported that, due to Re-organization of Zones, Divisions, in view of restructuring of GHMC, the jurisdictional responsibilities of the existing Police Commissionerates have been increased considerably. In order to maintain public order, enhance policing efficiency, ensure effective supervision, improve response time, and strengthen the overall law and order mechanism, the Director General of Police has proposed the reorganization of the existing Police Commissionerate with jurisdiction over the areas specified in the Annexure and requested the Government to issue necessary notification.

2. Government, after careful examination of the matter, hereby decides to reorganize the territorial limits of existing Hyderabad City Police Commissionerate with the jurisdiction over the areas specified in the Annexure.

3. Accordingly, the following Notification shall be published in an Extra-Ordinary issue of the Telangana Gazette, dated: 29.12.2025:
