Office Order No. 54/2024

It be noted that in pursuant to letter no. 668/Admn.Misc. dated 28.11.2023 of the Hon'ble High Court of Jharkhand, Ranchi, Accessibility Committee was constituted for the District Court under this Judgeship as per the relevant mandate laid down under heading number XIV of the Standard Operating Procedure for Preparing Accessible Court Documents, 2022.

Perused letter no. 150/Admn.Misc. dated 04.03.2024 of the Hon'ble High Court of Jharkhand whereby the Hon'ble Court has been pleased to direct to re-constitute the Accessibility Committee by including a member from the Bar Association of the Sub-Divisional Court, preferably a differently-abled advocate to properly address the accessibility issues for Persons with Disability in Sub-Divisional Court. Also perused the letter no. 151/Admn.Misc. dated 04.03.2024 of the Hon'ble Court.

In view of the above directions of the Hon'ble Court, Accessibility Committee is re-constituted in this Judgeship comprising of :

This Accessibility Committee of the Judgeship shall conduct a meeting on quarterly basis and Minutes of the same be duly submitted before the undersigned for its onward transmission to the Hon'ble Court.

The Committee should publish, on a quarterly basis, data as to how many requests for accessible filings/court documents or any other reasonable accommodation were made to it and how many amongst them were disposed of. Any accessibility challenges faced by the disabled in accessing the justice system (in addition to those mentioned in point 28) can be brought to the Committee's attention and must be dealt with in a swift and effective fashion, in a manner consistent with the Rights of Persons with Disabilities Act, 2016, and the rules framed thereunder.

Further, the following staff are hereby nominated as Nodal Officer separately for the District Court, Jamshedpur and Sub-Divisional Court, Ghatshila in the manner as below.

For District Court, Jamshedpur:

For Sub-Divisional Court, Ghatshila:

The aforesaid staffs being Nodal Officer will look after the problems of the litigants who are differently-abled. The mobile number of the said Nodal Officer be uploaded on the official website of the Judgeship and also the same be displayed at the gates of the Civil Courts both at Jamshedpur and Ghatshila.

The Judge-in-Charge (Nazarat), Civil Court, Jamshedpur/Ghatshila is directed to ensure the availability of adequate number of wheelchairs in the respective Civil Courts for differently-abled persons, as per direction of the Hon'ble Court.

Let a copy of this order alongwith copy of Standard Operating Procedure for Preparing Accessible Court Documents, also with contact details as well as email id of the Accessibility Committee be published in the official website of this Judgeship.


