Whereas all the three courts are interaila exercising their functions as Special/Fast Track courts in respect of some offences trible by the Special Judges under the relevant statues.

Whereas barring the cases under Special offences, all the three Sessions Courts have been attending to the criminal business under the other criminal major/minor acts, concurrently.


Whereas it is expedient to make some provision for the smooth distribution of the criminal business exercisable by all the three Sessions Courts.

Now, therefore, I Mohammad Yousuf Wani, Principal Sessions Judge, Baramulla in exercise of my powers vested under sections 10, 400 and all other enabling provisions under the Code of Criminal Procedure 1973, is convinced to issue a fortnightly Rotational Roster in respect of the distribution of the Criminal Miscellaneous matters I.e Bail Applications, (Regular & Anticipatory), Release applications, Remand Applications and all other Miscellaneous application among the court of undersigned and two Additional Sessions Courts at Headquarter Baramulla.

However, the matters to be entertained and disposed of as per the Roster shall be presented

before this court for the assignment thereof as per Roster. Police reports/Challans U/s 173 Cr.PC will not be governed by the Roster and such cases shall be assigned by the undersigned as per the suitability and pendency ratio. The matters shall be entertainable by the Courts through available mode (Physical or virtual) as per the Hon'ble High Court orders.


