Whereas, it has been regularly observed that most of the advocates especially juniors file pleadings of different nature before the courts in the District Baramulla in a casual and cavalier manner whereby multidimensional difficulties arise for the Bench, Court staff and especially the litigant public;

Whereas, the pleadings filed before the different Courts do not bear the names of the concerned advocates filing the same;

Whereas, the advocates usually resort to copy-cut-paste without scrutinizing the process which results in the incorporation of different facts in a particular pleading.

In this connection, it is directed that all the pleadings to be filed before different courts in the District Baramulla should be so filed strictly in accordance with the provisions of the law especially the Code of Procedure with the strict observance of the following mandatory requirements:-

- 1. All the Suits/Appeals/Applications of civil nature shall be accompanied with a duplicate copy and further copies equivalent to the number of defendants/respondents/non-applicants.
- 2. All the bail Applications and other criminal miscellaneous matters shall also bear the name of the advocates with signature and date. The said motions shall be accompanied with the copies equivalent to the number of the Respondents.
- 3. All the pleadings shall bear name of the counsel and his signature with date.
- 4. All the pleadings after being presented before the concerned Presiding Officers shall be got e_registered at the office counter.
