They shall also establish a help desk to ensure the hassle-free virtual disposal.
- The Ld. Duty Magistrates shall maintain the records in their concerned courts and shall intimate the Court of the Chief Judicial Magistrate, Sopore, after the vacations as to matters dealt during their vacation duty.
- I.d. JMIC Dangiwachha has desired to hold sitting in the court of Ld. Munsiff, Baramulla during the vacation period, so his sitting during vacations shall be in the court of Munsiff Baramulla.
- The Ld. Duty Magistrates are directed that, once the vacation period is over all pending applications shall be sent to the concerned courts having jurisdiction to trial or commit for trial.
- The Ld. Duty Magistrates shall utilize services of their respective staff and Prosecution staff unless special rooster is made by Department of Prosecution.


