

**DOCUMENTS TO BE SUBMITTED AT THE TIME OF CERTIFICATE  
VERIFICATION**

- a) Original certificates of academic qualifications, such as, marks lists, pass certificates, certificate evidencing date of birth, latest community certificate issued by the competent authority in case of SCs., STs., and BCs., and latest Economically Weaker Section(EWS) Certificate issued by the competent authority in respect of EWS candidate.
- b) The certificate in respect of BCs, shall show specifically the classification of the group.
- c) Two sets of Photostat copies of certificates duly attested by the Gazetted Officer are to be submitted at the time of verification of the certificates.
- d) The Other Backward Class (OBC) Certificates will not be considered.
- e) Discharge Certificate for Ex-servicemen candidates.
- f) Certificate in respect of Local candidates in terms of The Telangana Public Employment(Organization of Local Cadres And Regulation Of Direct Recruitment) Order, 2018,Vide G.O.Ms.No.124, General Administration (SPF-MC) Department, dt:30.08.2018, as specified in the General Instructions hereunder. If certificates in proof of local candidature are not in accordance with these instructions, the applicant will be treated as non-local.
- g) In case of Differently-abled Persons, the certificate issued by the Medical Board specifying the nature of disability and percentage of disability.
- h) No-objection Certificate from Employer (if employed anywhere).
