ADVERTISEMENT

Applications are invited in Standard Form as published in Assam Gazette in Part IX from eligible candidates/applicants who are citizens of India as defined in Articles 5 and 6 of the Constitution of India for engagement of **01 (one) Driver (Contractual)** for Multi-Utility Vehicle in the office of the District Legal Services Authority, Darrang, Mangaldai at a monthly remuneration of Rs. 15,000/- (Rupees Fifteen Thousand) only. The 21 candidates who had already appeared in the driving skill test held on 05.07.2026 in terms with earlier advertisement dated 15.05.2026 need not apply afresh and they may participate in the selection process and their candidature will remain valid.

The engagement is purely temporary and contractual in nature and may be terminated at any time subject to discharge of duties to the satisfaction of the authority. The contract period may be extended depending upon requirement and performance.

Selection Procedure:

All eligible candidates whose applications are found valid and accepted shall be called to appear in a **Driving Skill Test carrying 40 (forty) marks**. Candidates securing the qualifying/passing marks of **30 out of 40 (forty) marks** in the Driving Skill Test shall thereafter be called to appear for an **Interview carrying 60 (sixty) marks**. The final merit list shall be prepared on the basis of the aggregate marks obtained by the candidates in the **Driving Skill Test and Interview**.

How to Apply:

1. Candidates must submit self-attested copies of relevant testimonials/educational certificates, age proof, caste certificate, valid employment exchange registration card, valid driving license (LMV), experience certificate (if any) and two passport-sized photographs along with the application and paste a photograph in the application form in the required space.

2. Candidates are required to provide their phone number (preferably WhatsApp No.) and email ID in the application form.
3. Candidate must be an Indian Citizen as defined in articles 5 and 6 of the Constitution of India and ordinary resident of Assam.
4. A candidate must not be less than 18 years and not more than 40 years of age as on **01st January, 2026**. In appropriate cases, relaxation of age will be admissible as per the existing rules of Government of Assam.
5. Eligible Candidates will have to produce **original** testimonials regarding educational qualifications, date of birth, caste, valid employment exchange registration card, valid driving license (LMV) working experience (if any) at the time of driving skill test and interview for the purpose of verification and scrutiny.
6. Application should be addressed to the **Chairman, District Legal Services Authority, Darrang, Mangaldai**.
7. The last date fixed for receipt of applications is **01/08/2026** till 04:00 PM. Candidates are required to submit their applications in the Drop Box set up for the purpose in the office of the District Legal Services Authority, Darrang. The Postal address of the office is "**DISTRICT LEGAL SERVICES AUTHORITY, DARRANG, MANGALDAI, WARD NO:1, DRDA Road, NEAR TREASURY OFFICE, PIN:784125.**" This Authority will not be responsible for any postal delay. No application shall be received after 04:00 PM of **01/08/2026** (in any mode)
8. Incomplete or unsigned applications and applications submitted without annexing required valid documents or required no. of photographs will be summarily rejected without assigning any reason thereof.
9. No TA/DA will be admissible to the candidates for appearing in the driving skill test/signage and interview.
10. Canvassing directly or indirectly shall be liable for disqualification of the candidate.
11. The decision of the Selection Committee shall be final and binding in respect of any dispute arising out of the recruitment process.
12. The list of eligible candidates and other information relating to the recruitment process will be uploaded from time to time in the official website of the Darrang District Judiciary i.e., <https://darrang.dcourts.gov.in>. No individual call letters will be issued for the driving skill test or interview. Candidates are advised to visit the official website regularly for updates.
13. The information submitted by an applicant in his/her application shall bind the candidate, and if any information is found to be false or incorrect, his/her candidature shall be cancelled forthwith and he/she shall also be liable for criminal prosecution.
14. The admission of candidates at all stages of the selection process shall be purely provisional and subject to fulfilment of the prescribed eligibility conditions. Applications shall be subject to scrutiny at every stage, and shall be rejected if any defect or discrepancy is detected.
15. The Office of the District Legal Services Authority, Darrang, Mangaldai reserves the right to cancel the advertisement, alter/modify or change any terms and conditions, including the selection criteria etc. specified in this advertisement.
16. Any condition(s) not specifically provided for herein shall be decided by this Authority from time to time.
17. The list of selected candidates shall be published in the official website of the Darrang District Judiciary in due course along with the 21 candidates who had already appeared in the driving skill test held on 05.07.2026 in terms with the earlier advertisement dated 15.05.2026.

19. If selected, the candidate have to submit a declaration that "I and my family members are neither beneficiaries of the Orunudo Scheme" or have voluntarily opted out as on the date of appointment/engagement".

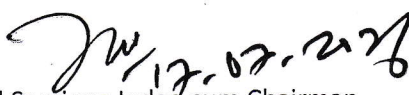
