**ORDERS:**

In compliance to orders of the Hon'ble High Court under reference 2<sup>nd</sup> cited, and considering the candidature of the individual in the oral interview held on 19.11.2022, the Principal District and Sessions Judge, is pleased to select and appoint the following retired Judicial Employees, on a contract basis to work in the Court of Fast Track Sessions Judge for expeditious disposal of cases of Rape & Protection of Children against Sexual Offences (POCSO) Act, Yadadri-Bhongir.

Sri Batte Eshwaraiyah, Senior Superintendent (Retired) R/o H.No.2-2-127/64/C, Vijayapuri Colony, Near Sai Baba Temple 2<sup>nd</sup> lane, Uppal, Hyderabad - 500 039 is appointed as Senior Superintendent against the post sanctioned vide 1<sup>st</sup> reference cited above, purely on contract basis and posted to work in the Court of Fast Track Sessions Judge for expeditious disposal of cases of Rape & Protection of Children against Sexual Offences (POCSO) Act, Yadadri-Bhongir, in the post kept vacant.

Sri Kanukurthi Verkateshwarlu, Junior Assistant (Retired) R/o H.No.6-107/2, Goundlavada, Ramannapet is appointed as Junior Assistant against the post sanctioned vide 1<sup>st</sup> reference cited above, purely on contract basis and posted to work in the Court of Fast Track Sessions Judge for expeditious disposal of cases of Rape & Protection of Children against Sexual Offences (POCSO) Act, Yadadri-Bhongir, in the post kept vacant.

The above individual shall report for duty before the Presiding Officer concerned within seven (07) days on receipt of this order, failing which the appointment would be deemed to have been cancelled and no further correspondence will be entertained.

The period of contract of the above individuals shall come into force from the date of joining in the post or till the actual need ceases or attaining the age of 65 years, whichever is earlier.

The persons appointed in Fast Track Sessions Court for expeditious trial and disposal of Rape and POCSO Act cases in the Unit of Yadadri-Bhongir district, on contract basis shall be paid remuneration as fixed by the Government from time to time vide reference 3<sup>rd</sup> cited above.

The above individuals are required to submit a Physical Fitness Certificate issued by a Medical Officer not below the rank of an Assistant Civil Surgeon at the time of reporting for duty and enter into a contract agreement in the proforma prescribed for submission to the Hon'ble High Court.

The persons appointed shall be purely on contract basis as per Rule 9 of Telangana State and Subordinate Service Rules, read with standing orders of the Hon'ble High Court issued from time to time and they shall not be regarded as a member of service and shall not be entitled for preferential right to any other appointment and liable to be terminated at any point of time without any notice.
