In compliance of the Circular instructions of the Hon'ble Telangana State Legal Services Authority, Hyderabad, the **National Lok Adalat is scheduled on 13-08-2022** (Second Saturday).

In this connection, all the Presiding Officers of the courts in the unit are required to identify the cases ( category wise ) which are depicting on NJDG and which are likely to be settled before ensuing National Lok Adalat and submit the statistical information along with list of pending civil and criminal compoundable cases including Sec.138 of N.I. Act ( category wise ) & Pre-Litigation matters by **27-07-2022** and also list of settled cases immediately after the completion of the National Lok Adalat in the prescribed format. Further, to direct the concerned Court Superintendents and Bench Clerks for strict compliance in furnishing of the statistical information by following the NJDG system CIS 3.0, nominate two Bench Clerks, one Typist and one Attender to assist the Lok Adalat Benches on the scheduled National Lok Adalat and submit the particulars of one day basic of the nominated Staff along with photo copies of Saving Account Pass Book enable to make the payment of remunerations.

The Chairmen of Mandal Legal Services Committees, Ramannapet, Alair & Choutuppal are hereby requested to conduct the meetings with all stake holders as per the circular guidelines and instruct the concerned staff to maintain the Lok Adalat Registers (Entry & Disposal with result). Copy of Circular & Proforma are herewith enclosed.
