Sub: High Court for the State of Telangana – No religious functions shall be organized in the District Judiciary in the State of Telangana either by Advocates or by Bar Associations – Reiterating the earlier Circular Instructions – Orders issued - Reg.


It is brought to the notice of the High Court that religious functions / religious ceremonies are organised in the Court premises of the District Judiciary.

You are aware that the High Court in the references cited issued circular instructions instructing all the Judicial Officers in the State not to use the Court premises for religious functions / religious ceremonies and the functions organized by the Courts should be avoided.

The High Court having considered the present scenario, viewed it very seriously and reiterates the earlier circular instructions issued in the references cited directing all the Unit Heads in the State to see that no religious functions / religious ceremonies and functions organised by the Courts, are organized in Court Premises by the Advocates / Bar Associations and others in future.

Further, all the Unit Heads are directed to instruct the Judicial Officers working under their control to follow the instructions scrupulously.

Any deviation in this regard will be viewed seriously.
