The above appointment of the individuals are purely on temporary basis and their services are liable to be terminated without any notice or assigning any reasons and the services of the individual shall be covered by the Contributory Pension Scheme as per G.O.Ms.No.653, 654 and 655, (Fin. Pension.I) Department, dated 22.09.2004 issued by the Govt. of Andhra Pradesh adopted by the Government of Telangana.

They shall report to duty within (01) week from the date of receipt of this order to their respective stations. If they do not join duty within the stipulated time, the appointment shall be treated as automatically cancelled and they shall forfeit their right of appointment.

The individuals shall produce a **Physical Fitness Certificate** (Age and health Certificate) issued by Government Medical Officer not below the rank of a Civil Surgeon at the time of reporting to duty as per Rule 10 of Fundamental Rules.

The above Candidates are hereby informed that the seniority will be fixed among all the provisionally selected candidates based on the merit list furnished by the Hon'ble High Court. There shall not be any claim with regard to seniority among all the candidates in future.

The above said Candidates shall, for the due and faithful performance of duties attached thereto, deposit an amount of **Rs.10,000/-** (Rupees Ten thousand only) in the shape of Fixed Deposit Receipt drawn in their favour towards security within one month from the date of joining duty of their respective stations. In the event of said candidates leaving their posts by

any reason i.e., resignation etc., within two years the deposited amount of Rs.10,000/- stands forfeited.
