



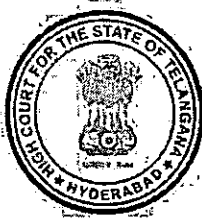

I am to further inform that, as per the directions of the Hon'ble e-Committee, Supreme Court of India the work is entrusted to the Telangana State Nodal Agencies i.e. Telangana State Renewable Energy Development Corporation Ltd., (TSREDCO) for provision of G. C. R. T. Solar P.V. systems at the Court complexes housed in own Government buildings and ICT hardware to the Telangana State Technology Services Ltd., and provision of Porta Cabins for establishment of eSewa Kendras to M/s. Sunrise Portable Cabins Industry, Hyderabad. For provision of the above infrastructure, the representatives of the Vendors will approach the Courts shortly. I request you to instruct all the Courts concerned to coordinate with the representatives of the Vendor(s) and see that the deliveries and installations are completed smoothly within the stipulated time i.e. on or before 15th March, 2024 and also to ensure the safety of electrical items with proper electrical earthing, without fail. If required, the LAN Vendor may be permitted to execute the LAN work even after office hours


1. Administrative Officer / Chief Ministerial Officer (CMO)
