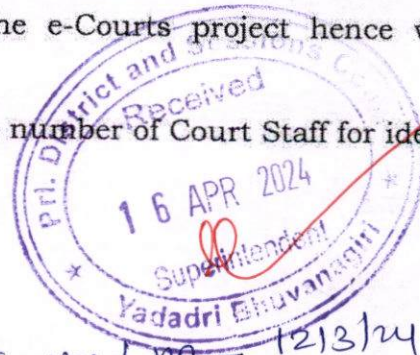
**Category C (Court Staff with Technical Qualification):**

1. Court Staff possessing Technical Qualification in Computers (BE, B.Tech, B.Sc(CS), MCA, M.Tech or computer-related fields Bachelor/Master Degree in Data Science, Artificial intelligence etc.
2. Diploma or certificate courses in computers need not be included under Technical qualification.
3. The Court Staff must be willing to be a trainer and take up various activities of the e-Courts project hence willingness is mandatory.
4. There is no limit on the number of Court Staff for identification as Master Trainers.

**Category D (List of Potential Court Staff ) :**

1. Court Staff who do not hold a technical qualification, but tech-savvy, well versed with technological updates, and proactive in using ECT tools in day to day court administration.
2. Diploma or certificate courses in Computers may be considered under this category.
3. The nominated Court Staff must be **willing** to be a trainer and take up various activities of the e-Courts project hence willingness is mandatory.
4. Court Staff recruited after 2015 may be considered under this category.
5. 2 persons per district may be considered under this category.

I am to inform that the interested Court Staff including the Court Staff who had provided willingness earlier in the year 2022 are required to submit their willingness in writing in the proforma enclosed (Category C/Category D) and you are required to send list of willing Court Staff (excluding the names of existing Master Trainers) to the High Court by 18.04.2024.

I am to further inform that the Court Staff, who submit their willingness by 18.04.2024, will be provided with basic training for one or two days and after such training they are required to give demonstration on the topics provided by the Hon'ble eCommittee for their selection as Master Trainers.
