I am to state that the Hon'ble Apex Court in its Judgment dated 28-11-2017 in W.P. (Civil) No. 55 of 2013 filed by Sri Koshy Jacob Vs. Union of India and others has been pleased to observe that one or more District/ Additional District Judges can be appointed by the State Government in consultation with the High Court to deal with the cases of Damaged Public Property, either on whole-time basis or on part time basis.
