Land-Grabbers, Spurious Seed Offenders, Insecticide Offenders, Fertiliser Offenders, Food Adulteration Offenders, Fake Document Offenders, Scheduled Commodities Offenders, Forest Offenders, Gaming Offenders, Sexual Offenders, Explosive Substances Offenders, Arms Offenders, Cyber Crime Offenders and White Collar or Financial Offenders Act, 1986 (Act No.1 of 1986) - Extension of time empowering all the Collectors and District Magistrates and the Commissioners of Police in the State of Telangana to exercise powers there under for a further period of three months w.e.f. 15.06.2024 to 14.09.2024 - Orders - Issued.

ORDER:

In the circumstances reported by the Additional Director General of Police. Intelligence in his letter 5th read above, in continuation of the orders issued in the G.O. 4th read above. Government in exercise of the Powers conferred under sub-section (1) of section 3 of the Telangana Prevention of Detention Acts (Act. No. 1 of 1986), hereby extend the period to exercise powers of detention under sub-section (2) of section 3 of the said Act, to all the Collectors and District Magistrates and the Commissioners of Police in the State of Telangana, if satisfied, with respect to any Boot-leggers, Dacoits, Drug-offenders, Goondas, Immoral Traffic Offenders, Land-Grabbers, Spurious Seed Offenders, Insecticide Offenders, Fertiliser Offenders, Food Adulteration Offenders, Fake Document Offenders, Scheduled Commodities Offenders, Forest Offenders, Gaming Offenders, Sexual Offenders, Explosive Substances Offenders, Arms Offenders, Cyber Crime Offenders and White Collar or Financial Offenders, to make an order directing that such person be detained with a view to preventing him from acting in any manner prejudicial to the maintenance of the public order, within the local limits of their respective jurisdictions, for a further period of three months w.e.f. 15.06.2024 to 14.09.2024.
