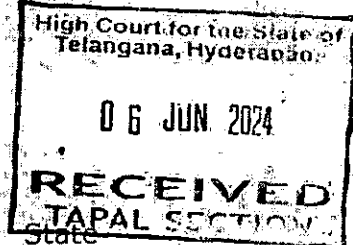

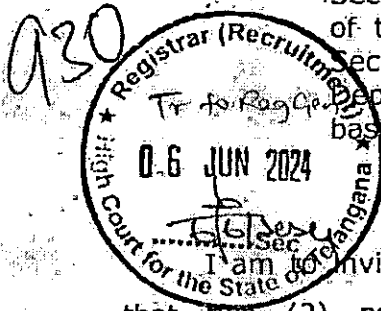

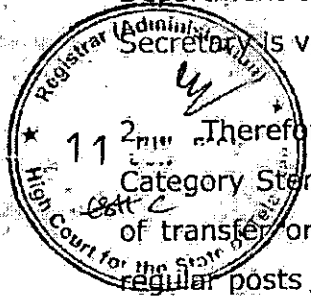

I am to invite your attention to the subject cited and to inform that two (2) posts of Special Category Stenographers in Law Department are lying vacant and one post of Private Secretary to Law Secretary is vacant w.e.f. 28.12.2023.



Therefore, it is proposed to take the services of the Special Category Stenographers and Private Secretary to Law Secretary, by way of transfer or on deputation basis, for a period of one year or till the regular posts are filled.

3. The post of Special Category Steno is carrying scale of pay of Rs.42300-115270 (RPS-2020) and the post of Private Secretary to Law Secretary is carrying the scale of pay of Rs. 54220-133630. As per Rule 3 of the Telangana State Secretariat Subordinate Service Rules, the following academic and technical qualifications are required for the post of Special Category Steno.


- (i) Must hold a Bachelors Degree of a University in India established or incorporated by or under a Central Act, Provincial Act or a State Act or by any Institution recognized by the University Grants Commission or any other equivalent qualification.

(and)

(ii) Must have passed the Government Technical Examination in Typewriting and Shorthand by Higher Grade either in Telugu or English and Typewriting Shorthand by Lower Grade in the other language in which they do not possess the Higher Grade qualifications.

4. Therefore, I request you to obtain and submit the applications from the eligible and willing employees from the High Court and District Judiciary for filling up the said posts on or before 29.06.2024.
