# **II.DISQUALIFICATIONS**

A person

1) Who is practicing Advocate OR

2) Who is Member of any State or Local Authority; OR

3) Who is a Member of the State Legislature or of the Parliament OR

- 4) who is having held an Officer under the State or the Union Government or any Local Authority, has been dismissed or removed or compulsorily retired from service or subjected to any other major penalty for misconduct,  $\mathbf{OR}$
- 5) who has been convicted and sentenced by a Court for an offence involving moral delinquency or is charged of any offence constituting moral turpitude proceedings are pending **OR**
- 6) A person unsound mind or who is deaf or mute or blind or suffering from Leprocy or any other contagious disease  $\mathbf{OR}$

7) A person adjudicated as insolvent or an undersigned insolvent, OR

- 8) A contract or a businessman or one interested in a subsisting contract or any work being done for Central or State Government or a Local Authority within whose limits the Special Magistrate has to discharge his/her duties, shall not be eligible.
- 9) If the individual refuses or does not join within fifteen (15) days from the date of receipt of the appoinment orders, he/she shall forfeit his/her claim to the post of Special Judicial Magistrate of Second Class;
- 10) The services of the Officers selected shall be liable to be terminated without any notice.

# III. REVOCATION OF POWERS OF SPECIAL MAGISTRATES

- 1) On appointment and while in service a Special Judicial Magistrate of II Class or Special Magistrate of any other category may be removed without being called upon to show cause if he/she fails to attend three consecutive sittings of the Court without a written permission of the Chief Judicial Magistrate, Suryapet as the case may be.
- 2) Powers conferred by the Court on Special Judicial Magistrate of II Class shall automatically stand withdrawn on his/her attaining the age of 65 years.

## IV. GENERAL INSTRUCTIONS
