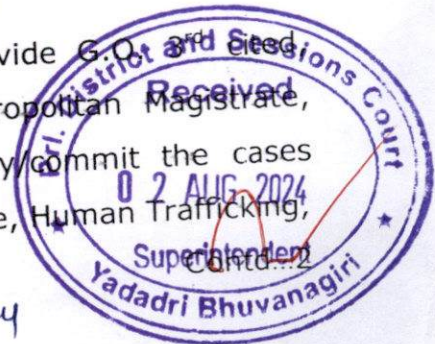

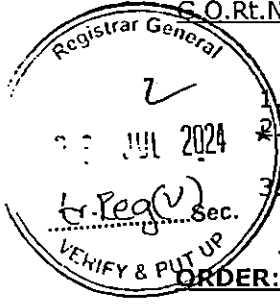

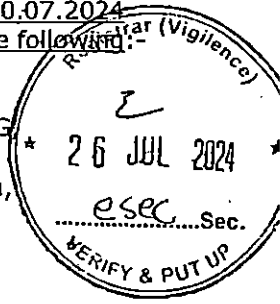

Whereas, the Registrar General, FAC Registrar (Vigilance), High Court for the State of Telangana, in the letter third read above, has stated that the Additional Director General of Police, Women Safety Wing, Telangana, Hyderabad, has requested the High Court to designate a jurisdiction Court in Hyderabad to process the cases of registration and investigation in Women Safety Wing on par with Crime Investigation Department (C.I.D) Telangana State, Hyderabad, so that the Station House Officer/ Investigating Officer of Women Safety Wing can process the case files for prosecution.
