

As per order dated 20.10.2023, the matter was referred for mediation to Hon'ble Sh. Justice Challa Kodanda Ram, former Judge

of the Telangana High Court. As per the Report received, the mediation has remained unsuccessful.

This petition has arisen out of an interim order of injunction granted in favour of the plaintiffs and the suit is still pending. Considering the fact that the Special Leave Petition has arisen out of an interim order, we deem it appropriate to direct the Senior Civil Judge at Bhongir, Nalgonda, to decide O.S.No. 8 of 2021 within a period of one year from today and if required, shorter dates may be given and the parties are directed to cooperate in expeditious disposal of the suit. Ordered accordingly.

In the meantime, the parties are directed to maintain status quo, as it exists today.

In view of above, the Special Leave Petition is disposed of.

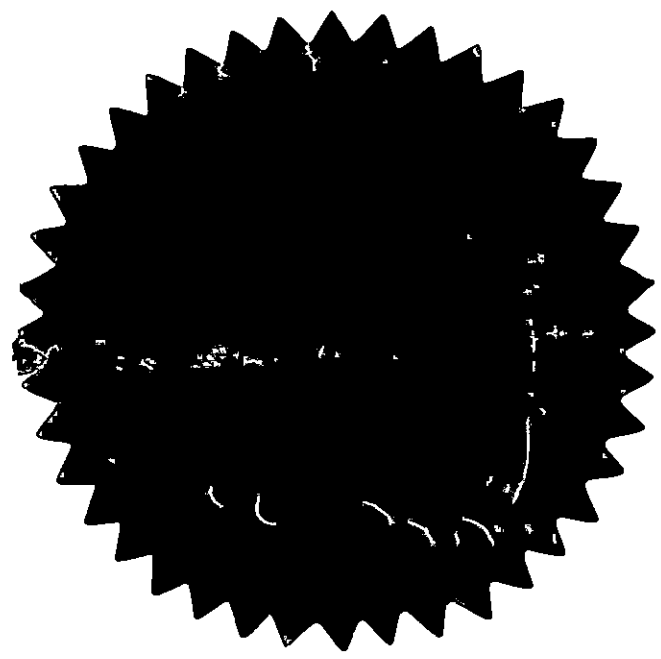
