In compliance of circular instructions regarding National Lok Adalat to be held on 14.09.2024, following instructions are issued for strict compliance and action taken report.

1. Every officer shall identify the more number of Civil and Criminal compoundable cases depicting in NJDG and also the cases at crime stage for settlement and submit the pendency and information of cases identified to the District Legal Services Authority, Yadadri-Bhuvanagiri in prescribed proforma enclosed herewith without fail on or before 12.08.2024 and virtual meeting is scheduled on 13.08.2024 at 5.15 p.m.regarding this. (Link will be communicated in due course).
2. Every officer shall conduct periodical coordination meetings with Advocates, Police ( Excise, Civil and Traffic ), APPOs, Bank and financial institutions, BSNL etc., with an interval of one or two days as per their convenience.

3. Every officer shall conduct pre-Lok Adalat sittings through constituted Benches.
4. All the officers shall take all possible steps for identifying more number of cases for settlement
5. All the officers shall personally monitor about the Notices to be issued and Notices to be served against the parties.
6. Wide publicity be given on conducting of National Lok Adalat in compliance of Circular instructions vide Roc.No.8/TLSA/2024, Dt:02.08.2024 of the Telangana State Legal Services Authority, Hyderabad.
7. All the Chairmen, MLSCs shall submit the copies of proceedings concerning constitution of bench proceedings and account particulars of staff to be nominated to attend duties in scheduled National Lok Adalat (Civil & Criminal Bench Clerks, One Typist/Steno and one Office Subordinate).
