In compliance of instructions issued in virtual meeting conducted by the Hon'ble Executive Chairman, Telangana State Legal Services Authority, Hyderabad on 11.09.2024, following instructions are issued for strict compliance and action taken report.

1. Hon'ble Executive Chairman, TLSA, Hyderabad fixed disposal target of eleven thousand cases in ensuing National Lok Adalat to the Yadadri-Bhuvanagiri District, as such in compliance of instructions every officer shall put all effective efforts in identifying and disposal of the targeted cases by conducting number of coordination meetings with APPOs, Advocates, Police and all stakeholders.

2. In the said virtual meeting, the Director of Prosecution who also participated in the meeting stated that all necessary guidelines issued to all the public prosecutors in telangana to extend their coordination in disposal of cases in the ensuing National Lok Adalat.
3. To conduct and monitor the disposals in pre-lok adalat sittings till National Lok Adalat i.e., 28.09.2024 and submit the disposal data daily to the District Legal Services Authority, Yadadri-Bhuvanagiri by 5.00 pm, enabling the undersigned to monitor and to issue necessary instructions/guidelines to all the concerned, to get more number of cases disposed.
4. All the officers shall personally monitor about the Notices to be issued and Notices to be served against the parties.
5. Ensure wide publicity through print and electronic media on conducting of National Lok Adalat in compliance of Circular instructions.
