Sub: High Court for the State of Telangana – Rules for Video Conferencing for Courts in the State of Telangana – Representation of the Nodal Officers of Telecom Service Providers - Instructions to all the Unit Heads in the State to record the evidence etc., of the experts/ Judicial Officers and other officials including Nodal Officers of Telecom Service Providers through Video Conferencing following the Video Conference Rules – Issued – Regarding.

Attention is invited to the High Court's Circular referred to above (Copy enclosed) wherein all the Presiding Officers in the State were instructed to record the evidence etc., of the experts/ Judicial Officers and other officials through video conference as far as possible instead of summoning them to attend the Courts physically and Unit Heads are also directed to instruct all the Presiding Officers in the respective Units to follow the instructions.

Having considered the representation of the Telecom Service Providers in the State, all the Presiding Officers in the State are instructed to record the evidence etc., of the experts/ Judicial Officers and other officials including Nodal Officers of Telecom Service Providers through Video Conferencing by following the Video Conferencing Rules unless Nodal Officer of the Telecom Service Provider Physical Presence is essential in the Case.

All the Unit Heads shall forthwith communicate the Circular to all the Judicial Officers in their respective Units with a direction to follow the instructions scrupulously.


