It is all noticed that the National Lok Adalat is scheduled on 28-09-2024 (Saturday).

In this connection, this office already issued instructions to all the Presiding Officers in this district to identify the cases (category wise & matrimonial cases) which are depicting on NJDG and which are likely to be settled before ensuing National Lok Adalat and settle the matters in Pre- Lok Adalat sittings through the Lok Adalat Benches constituted to the respective Courts.

The Commissioner of Police, Rachakonda also requested vide reference under 4th cited to conduct Pre Lok Adalat sittings specially on 21.09.2024, but it is already issued instructions to conduct Pre-Lok Adalat sittings for the purpose of settlement of more number of cases.

The Director of Prosecution also reported in virtual meeting that necessary guidelines already issued to all the APPOs to extent their coordination in disposal of cases in the ensuing National Lok Adalat.
