Adverting to the subject and references cited, I am to inform that the Government of Telangana has enacted Act No.14 of 2024, carrying out amendments to the Sections 5, 9 and 16 of Telangana Civil Courts Act, 1972, altering the Pecuniary Jurisdiction of the Civil Courts. The Government has issued G.O.Ms.No. 74, Law, L& J (Home Courts-A), dated 20-09-2024, appointing the 1<sup>st</sup> day of September,2024 as the date on which the provisions of the said Act shall come into force and the same was published in Telangana Gazette. As per the said amendment the original suits and proceedings initiated on or after 01.09.2024 exceeding the value of above Rs. 10 lakhs are to be dealt by the Senior Civil Judges.

Therefore, I am to request you to direct the Junior Civil Judges' working in your Unit to transfer original suits and proceedings initiated on or after 01.09.2024 exceeding the value of above Rs. 10 lakhs to the Senior Civil Judges in your respective jurisdiction for adjudication.
