Sub:- e-Courts Project, Phase-III – Implementing e-Filing in the District Judiciary from 18/11/2024 onwards – Intimation - Regarding.

The Hon'ble High Court of Telangana vide reference cited, has directed this authority to implement e-Filing i.e., online filing of cases from 18-11-2024 onwards in the Yadadri Bhuvanagiri District through the web portal https://filing.ecourts.gov.in/pdedev/

As directed by the Hon'ble High Court vide reference cited, all the Advocates are requested to follow the below mentioned instructions scrupulously for implementation of e-Filing in the Yadadri Bhuvanagiri District.

- 1. In Most of the Courts existing data is of the erstwhile composite State of Andhra Pradesh and the Advocate Bar Enrolment number/Registration numbers were registered with 'AP' and hence, the Enrolment numbers are not compatible with the present software/e-Filing portal. As per the e Filing portal, the prescribed Advocate Bar Registration number for Telangana State should be "TS/...../.....". Hence, all the Advocates are requested to update their old composite State Bar Enrolment number.
- 2. All the Advocates shall submit/update the details like Telangana Bar Enrollment Number, Address, District, Date of Birth, Gender, Mobile Number and Email ID for addition/updation of the same in NC DC CIS software and the Advocate registration data enables the Courts for effective implementation of e-Filing 3.0 and facilitates other e-services (sms, e-mail) also.
- 3. All the Advocates shall mandatorily affix/endorse their Unique Bar Enrollment Number on the Case bundle for effective implementation of e-Filing 3.0.

- 4. All the Advocates while submitting the Case documents through online in e-Filing 3.0, must, adhere to the e-Filing rules of the High Court for the State of Telangana.
- 5. All the Advocates are requested to update/submit their data in the respective Court establishment(s) as per point nos. 1 & 2, before registering in the e-Filing 3.0 portal at https://filing.ecourts.gov.in/pdedev/ for online case filing.

It is further informed that, the services of eSewa Kendra for scanning of case files for e-Filing are extended to all the e-Filing portal registered Advocates for free of cost, till further orders.
