2. In the G.O.13<sup>th</sup> read above, the recommendations of the Second National Judicial Pay Commission and recommendations of the Registrar General, High Court, Hyderabad were accepted by the Government and orders were issued sanctioning the Special Pay for Administrative Work as follows:-

**XV. Special Pay for Administrative Work**

a) Special Pay for Judicial officers doing administrative work shall be payable to:

- (i) Principal District and Sessions Judges : Rs.7000/- per month

- (ii) Other District Judges including I Additional District Judges entrusted with administrative work who have to generally spend time beyond Court working hours: Rs. 3500/- per month.
- (iii) District Judges presiding over Special Courts and Tribunals having independent administrative responsibilities: Rs.3500/- per month.
- (iv) CJMs and Principal Senior, Junior Civil Judges and other Judicial Officers having administrative responsibilities being in charge of independent Courts with filing powers : Rs.2000/- per month.
- b) The Special Pay is payable w.e.f. 01/01/2019 and Officers are entitled for arrears w.e.f 01/01/2019.

3. In the letter 14<sup>th</sup> read above, as per the following resolution of "Committee for Service Conditions of the District Judiciary" the Registrar General, High Court, Hyderabad has requested to issue necessary orders at the earliest on the matters as resolved by the Committee.

I

"The Committee resolved to address a letter to Govt., requesting for inclusion of all the Registrars (Judicial Officers), the Secretary to the Govt., Law (Legal Affairs, Legislative Affairs and Justice) and other Judicial Officers working on other duty in all cadres in the "Special Pay for Administrative Work" allowed by an order of the Hon'ble Supreme Court and as mentioned in G.O.Ms.No.4 at para XV at revised rates."

4. Government, after careful examination of the matter and in partial modification of the orders issued in G.O.13<sup>th</sup> read above, the following clause is hereby included to the point No..iv of point No. XV of G.O 13<sup>th</sup> read above.

"All the Registrar General and Registrar (Judicial Officers), the Secretary to the Government, Law (Legal Affairs, Legislative Affairs and Justice); Department and other Judicial Officers working on other duty in all cadres."

5. The Registrar General, High Court for the State of Telangana, Hyderabad shall take further action in the matter.
