In pursuance to the instructions of the Hon'ble High Court under references cited with regard to Action plan for Arrears reduction in District Judiciary and also in the Video Conferencing Meeting held on 26.03.2025 with the SCMC of the Hon'ble High Court, the Principal District Judge, Yadadri-Bhuvanagiri is pleased to instruct all the Judicial Officers in the Yadadri-Bhuvanagiri District to follow the instructions and guidelines as per Phase – III (January-June 2025) of Action plan and Dispose of the cases that are more than 20 years old cases (up to the Year 2004) and continue efforts to dispose of all the cases that are 20-10 years old cases (from 2005 to 2014).

Further, all the Judicial Officers are hereby directed to maintain the following information up-to-date every month and submit the same to this Court, so as to submit the same to the Hon'ble High court.

1. Number of civil cases where framing of issues is pending for over one month even after completion of pleadings
2. Number of Criminal cases where framing of charges has been pending for over one month.
3. Number of Civil Suits where any Interim application has been pending for more than three months.
4. Number of Pre Lok Adalat sittings conducted for resolution of oldest cases (Pre-2015) if no pre-2015 cases consider cases among oldest 50 cases as mentioned above.
5. Total Number of 'Unready cases' pending i.e., at the stage of appearance of the parties.
6. List of cases Stayed by the Hon'ble High court among oldest cases (Pre-2015) (if no or less than 50 pre-2015 cases consider cases among oldest 50 cases as mentioned above.)
7. List of cases stayed by the Hon'ble Supreme court in oldest cases (Pre-2015) (if no or less than 50 pre-2015 cases consider cases among oldest 50 cases as mentioned above.)
