

STATE PLAN OF ACTION / CALENDAR OF ACTIVITIES
FOR THE PERIOD FROM APRIL-2025-MARCH-2026

APRIL - 2025

1. Observe "World Health day" on 07.04.2025 in coordination with the Medical & Health Department, NGOs and create awareness on public health issues and remedies available, for their treatment & well being.
2. Conduct Legal Awareness Camp on Fundamental Rights and duties as envisaged under the Constitution on the occasion of "Dr. B.R. Ambedkar Jayanthi" on 14.04.2025.
3. Conduct visits to Juvenile Homes, Observation Homes, Oldage Homes, Children Homes and Spl. Homes along with Panel Lawyers and deficiencies if noticed, take necessary steps with the concerned stake holders under intimation to SLSA and send visit reports by 5th of succeeding month without fail.
4. Review of functioning of Legal Aid Clinics / Village Care and Support Centres and take steps for deletion of un-productive centres and setting up new centres wherever necessary. Also review the functioning of Front Offices, work of the PLVs, and take necessary steps for removal of PLVs on the ground of disqualification, if any, and also identify new enthusiastic PLVs.
5. Conduct Monthly Meetings of Monitoring & Mentoring Committees and submission of bi-monthly Monitoring & Mentoring Committee reports to the State Authority.
6. DLSAs shall conduct Awareness on the distractions of W.P. No. 1082 of 2020 Suhas Chakma Vs. Union of India and strengthen Prison Legal Aid Clinic (PLAC).
7. Conduct Under Trial Prisoners Review Committee Meeting as per the directions of the Hon'ble Supreme Court of India in WP (C) No.406 / 2013 in the case of In-human condition in 1382 prisons for the quarterly period viz April-June, 2025 and send data on the functioning of UTRC to SLSA as per the prescribed format.
8. Conduct Legal Literacy Camps (not less than (3) by DLSA's and MLSC's) including Legal Literacy Camp on Agriculture Legal Aid Clinic covering Farmer Legislations, Welfare Schemes for the benefit of the farming community etc. in the district.
9. Conduct Monthly Review Meetings of LADCs as specified under modified Legal Aid Defence Counsel Scheme, 2022 to monitor the work and performance of LADCs and send report in the prescribed format to SLSA by 5th of succeeding month without fail.

APRIL, 2025

1.	Conduct visits to Mental Health Establishments (State Government and Voluntary organizations), and homes for the disabled persons and report to the secretary DLSA, any deficiencies are noticed, take necessary steps on priority basis to rectify the same by addressing letter to concerned Departments.
2.	Conduct visits to Juvenile Homes, Observation Homes, Old Age Homes, Children Homes and Spl. Homes along with LSUM. If any deficiencies are noticed, necessary steps to be taken on priority basis under due intimation to State Authority. Further Interact with the inmates of homes. If found any person suffering with mental illness immediately report to the Secretary, DLSA to take further action in that regard by secretary DLSA as per scheme.
3.	Review the functioning of Mano Nyaya Legal Services Clinics (MLSC), ensure proper functions of Mano Nyaya Clinics as per provision 5.3.1.2 of the scheme.
4.	Conduct periodic meetings with Judicial Officers posted within district to ensure that persons with mental illness and persons with intellectual disabilities are informed about their right to avail free legal services, by the Judicial Officer adjudicating their case.
5.	Organize Legal Awareness Programmes in co-ordination with DMHP, involving psychiatrists and social workers on topics pertaining to legal rights, entitlements Remedies and (RPWD) Act, (Rights of Persons with Disability) Act, 2016, for persons with mental illness and persons with intellectual disabilities at Prisons.
6.	Conduct outreach and awareness programmes not less than (3) on NALSA (Legal Services to Persons with Mental illness & Persons with Intellectual Disabilities) Scheme, 2024 by LSUM in collaboration with Government Departments, Agencies, Educational institutions, Universities, NGO's, Civil Society Organizations having expertise in the feild of mental health.
7.	Conduct monthly meetings with LSUM and submit report to SLSA.
8.	Observe World Health Day on 7.4.2025 create awareness on public health and available schemes on health.

APRIL, 2025

1.	LSUC must visit and Conduct Awareness camps regularly in Child care Institutions i.e. Juvenile Observation Homes, Children Homes and Spl. Homes. If any deficiencies are noticed, necessary steps to be taken on priority basis under due intimation to State Authority.
2.	Visit to the Legal Services Clinics established at Police stations, JJBs, in compliance with NALSA (Legal Services Clinics) Regulations, 2011 by the LSUC and review the functioning of clinics.
3.	Organize Sensitization programme to different stake holders on The Child and Adolcent Labour (Prohibition and Regulation) Act 1986, The Prohibition of Child Marriage Act, Protection of Child Rights, right to free and Compulsory Education, POCSO Act etc., Kasthurba Gandhi Baliki Vidyalaya Residential school.
4.	Organize Legal Awareness Programmes at villdage level/area wise in co-ordination Social Workers, Disabled People's Organization to sensitize the people on the Victim Compensation Scheme, 2015 and POCSO act and Child Marriages issues.
5.	Conduct outreach and awareness programmes not less than (3) on NALSA (CHILD FRIENDLY LEGAL SERVICES FOR CHILDREN) SCHEME, 2024 by LSUC to all stake holders in collaboration with DCPU, JJB Members, DHO, DCO, District level Disability & SWO, NGO, Social workers, Civil Society Organizations having expertise in the child care rights.
6.	LSUC may organise awareness programs for children to facilitate their admission/re-admission in schools through various State and Central Programmes like the National Institute of Open Schooling, State Open Schools, Indira Gandhi National Open University etc.
7.	Observe " World Health Day " on 7.4.2025 and Create awareness on public health and available schemes on health to the common public in your area.
8.	Conduct monthly meetings with LSUC and submit report to SLSA.
