In the above the year shall be "2022" instead of "2021"
i.e. Sl. No. **21 P.R.C. No. 693/22 U/S 294/506 I.P.C.**
- c) Sl. No. 24 P.R.C. No 3750/2017 U/S 341/352/294/352 I.P.C.
In the above the case-type shall be "G.R." instead of "P.R.C".
i.e. Sl. No. **24 G.R. No 3750/2017 U/S 341/352/294/352 I.P.C.**

Therefore, I kindly request your prompt action by issuance of a corrigendum or any other orders as your honour may deem fit and proper to rectify these discrepancies and published through the same channel used for the original letter.
