As technology continues to progress, new avenues open for the implementation of traditional business strategies. One such area that presents myriad opportunities, and pitfalls, for a modern business is that of Internet marketing. The effective exploitation of Internet marketing strategies, including necessary conversions of existing paper-based marketing initiatives to electronic versions, allows a business to build a larger client base and then leverage that base into increased revenue opportunities. A business may charge non-competitive companies a fee to allow them to piggyback onto an existing marketing campaign or create an auxiliary website which, under the auspices of providing information or advice, offers links to a sales site. While the opportunities for increased revenue are abundant, so are the potentially damaging risks. Inappropriate or misguided marketing strategies can result in the creation of a negative brand image and the loss of potential clients. Common transgressions in the field of Internet marketing include such obvious negatives as use of spam emails, unfocused solicitations and inclusion of large attachments that can slow down modem connections, or the sending of multiple messages to the same client list. Businesses engaging in these practices as a result of a misguided or incomplete marketing strategy will see a potential loss of client base and generate negative word-of-mouth. Another shortcoming in the field of high technology marketing concerns the lack of necessary research into the type of website design that will optimize product or service exposure. Many businesses fail to recognize the importance of linking a site to relevant search engine key phrases. Use of intuitive key phrases, resulted in a successful hit or link to a specific site. This can be explained by the relative paucity of users who actually use such phrases in their query search as well as by the presence of multitudes of companies.
