TERMS AND CONDITIONS

1. The bid will be confirmed in favour of the bidder quoting the highest rate above the minimum bid value decided in respect of the unserviceable/obsolete E-waste items and broken/unused furniture. The auction will be held in the District Judiciary Complex, Lakhimpur.
2. The bidder shall submit written bids in closed cover in the prescribed proforma (Annexure-A) with all the fields filled up properly in BLOCK LETTERS, with non refundable court fee stamp of Rs. 8.25/- only, on or before 20/06/2024 at

- 04:30 p.m. along with certificate of authorization for disposal of E-waste issued by the Appropriate Authority and other relevant documents as applicable.
3. Earnest Money Deposit is to be submitted by the interested bidder by NSC from any post office pledge in favour of 'District and Sessions Judge, Lakhimpur, North Lakhimpur. Bids without EMD will not be considered and shall be rejected.
 4. The bid will be opened on 21/06/2024 in the establishment of District and Sessions Judge, Lakhimpur, North Lakhimpur.
 5. For inspection and other details in respect of the E-waste items and broken/unused furniture, interested parties can visit the District Judiciary, Lakhimpur on 30/05/2024 and 31/05/2024 from 03:00 p.m. to 4:15 p.m. (during 2nd half).
 6. The written bids shall not be less than the minimum bid value of the unserviceable/obsolete E-waste items and broken/unused furniture as mentioned but may be more than that. The highest price offered by the bidder will be selected.
 7. On deposit of full and final payments, the auctioned E-waste items and broken/unused furniture will be handed over to such bidder.
 8. The office of the District and Sessions Judge will deal with bidder directly and no middlemen/agents/commission agent etc. would be allowed to represent the bidders and the middlemen/agents/commission agent etc. will not be entertained by the office. At the bidding, any bidder trying to form cartel with other bidders to otherwise influence the bidding process shall be evicted and stern action as per law will be taken.
 9. Conditional bid will not be entertained. If the bid is withdrawn by the concerned party at any time after it is provisionally accepted, the entire money already deposited by him/her shall stand forfeited.
 10. The District & Sessions Judge, Lakhimpur, North Lakhimpur, in its discretion, reserves the right to reject or accept any or all the bids, partly or completely, at

any time without assigning any reason there for. The decision of the Board conducting the auction shall be final.

11. It shall be presumed that the bidder has fully inspected the unserviceable/obsolete E-waste items and broken/unused furniture before the auction. The District and Sessions Judge, Lakhimpur, North Lakhimpur and Board shall not be responsible and shall not entertain any complaint in respect of any defect in the E-waste items and broken/unused furniture.
