Child Care Leave prayer of **Smti. Alee Borgohain, Wages Basis (minimum scale of pay of LDA), O/o the Civil Judge (Jr. Div.) No. 1, Lakhimpur, North Lakhimpur** for a period of 20 (Twenty) days w.e.f. 10.03.2025 till 29.03.2025 (prefixing 08.03.2025 & 09.03.2025 being 2nd Saturday and Sunday, Sufficing 30.03.2025 & 31.03.2025 being Sunday and Id-UL-Fiter respectively), has been rejected, on the following grounds:-

1. Firstly, the applicant has submitted her application on 06.03.2025. But as per Hon'ble Gauhati High Court, vide Order dated 31.03.2021 No. HC.V-98/2015/262/Estt. Point No. 5 "All the leave applications shall be submitted fairly in advance by the Officers/staff, preferably 07 (Seven) days prior to availing leave".
2. Secondly, she has already availed other nature of leave on 07.03.2025 casual leave on account of demise of her brother vide order of the learned Civil Judge (Jr. Div.) No. 1, North Lakhimpur, Lakhimpur and again availed casual leave on 10.03.2025, 17.03.2025, 18.03.2025 & 19.03.2025 on the same ground, allowed by the learned Civil Judge (Jr. Div.) No. 1, North Lakhimpur, Lakhimpur. But as per Notification No. FEG.11/2013/Pt-II/28, dated 31.07.2015, SR-121 (2) Point No. (xi) "The period of earned leave or any other kind of leave already sanctioned or availed shall not be converted into Child Care Leave (CCL) with retrospective effect" and employee is on leave from 07.03.2025.

Inform all concerned accordingly.
