Applications are invited for the post of Para Legal Volunteer in the District of Lakhimpur, from the local residents of Lakhimpur District, Assam. The applicant should have the following eligibility criteria to apply for selection to the post of para legal volunteer.

ELIGIBILITY

- 1. He/ she must be a citizen of India and should not be less than 18 years from the date of application.
- 2. He/ she must be Matriculate or equivalent with a capacity for over all comprehension.
- 3. He/ She should be of a good moral character.
- 4. He/ She must not belong to any political party.

- 1) Teachers (Including retired teachers)
- 2) Retired Government Servants and senior citizens.
- 3) M.S.W students and teachers
- 4) Anganwadi Workers.

- 6) Students and Law Students (Till they enroll as lawyers)
- 7) Members of non-political, Service oriented NGO's and Clubs.
- 8) Members of women Neighborhood Groups, and self Help Groups including of marginalized groups.
- 9) Educated prisoners with good behavior, serving long term sentences in prisons.
- 10) Any other person whom DLSA deems fit to be identified as PLV.

Filled up applications forms along with self- attested copies in respect of Caste, Age, Educational Qualification, proof of residence and work experience if any should reach the office of DLSA between <u>10:30 am to 5.00 pm on or before 22/05/2025</u>

SELECTION PROCESS

The selection of PLV's shall be made by a Committee Chaired by the Chairman District Legal Services Authority and Secretary DLSA shall be one of its members. The third member shall be selected by the Chairman DLSA at his/ her discretion.

METHOD OF SELECTION

The Selection Committee is entitled to use its discretion and shortlist the number of candidates for interview depending upon the number of applications received. Incomplete application will be rejected. No application will be accepted after the last date fixed. Preferably PLV's shall be selected from persons, who do not look up to the income they derive from their service as PLV's but they should have a mindset to assist the needy in society.

<u>NOTE</u>: The appointment of PLV is not a Job and does not carry any salary, wages or remuneration except honorarium fixed by DLSA from time to time. Honorarium of PLV is Rs 500/- per day per work.


