Candidates must submit their application in standard form along with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Experience Certificate (if any) & Copy of Employment Exchange Registration Card along with 3 (Three) copies of recent passport size photographs, duly signed by the candidate on the reverse side.
- 4. Candidates already serving in Govt. Department should submit their applications through proper channel and if selected will have to submit "No Objection Certificate" from their employer at the time of joining.
