Applications are invited in Standard Form as published in Part-IX of the Assam Gazette for selection of panel of fresh Advocate Commissioners, in the respective Civil Courts of Lakhimpur District including Dhakuakhana Sub-Division for recording evidence in Civil Suits and Proceedings as per the Hon'ble Gauhati High Court Civil Court Commissioners Rules, 2015.

Eligible criteria for selection as Commissioner :

- (i) Any Advocate practicing in the Courts of Lakhimpur district.
- (ii) Any practising Advocate, who has completed 5(Five) years practice in the Bar.
- (iii) A willing Advocate shall give a declaration that no Criminal or Civil Cases are pending in any Court and no disciplinary proceeding is pending in the Bar Council against him/her.

How to apply :

The intending candidates who fulfill the above qualifications/ conditions can apply by filling his/her application in Standard Form with self-attested copies of relevant documents alongwith two copies of recent passport size photographs and Mobile/WhatsApp number addressing to the "District & Sessions Judge, Lakhimpur, North Lakhimpur" under the caption "Application for selection of Advocate Commissioner for Lakhimpur District/Dhakuakhana Sub-Division" .

The applications should be reached within **15(Fifteen) days from the date of publication of the inviting notice.**

The candidates shall have to appear for an interview before the Selection Committee to be notified later at their own expenses and the original documents regarding qualification, experience, Bar certificate, eligibility etc. as applicable, will be required to be produced at the time of Oral interview/Viva-Voce.

Canvassing directly or indirectly shall disqualify a candidate.



No separate Call Letters will be sent to the Candidates called for Oral Interview/Viva-Voce. Further, candidates will be intimated through their given Mobile number.

The Candidates are not allowed to carry **Mobile phone/Smart watch and other electronic devices** in the Interview/Viva-Voce.

Application forms which are incomplete in any respect, such as, without photograph, signature and valid mobile number etc. to be rejected summarily.

Date and time of the Oral Interview/Viva Voce alongwith the **Accepted List** and **Rejected List** of the Applicants will be intimated in due course through official website of District Judiciary and in the Notice Board of respective office.

Remuneration :

As per Rules, a Commissioner shall be entitled to a fee of Rs. 300 (Rupees three hundred) per witness towards remuneration. In case, the cross-examination of a witness could not be completed in one day and continued beyond the day, Commissioners fee shall be Rs. 200 (Rupees two hundred) per day for such witness.

Selection Procedure :

The Selection Committee shall test the knowledge of the advocates on relevant provisions of the Code of Civil Procedures of Gauhati High Court Civil Rules and Order, relevant provisions of the Indian Evidence Act and General Aptitude. The Selection Committee shall prepare a select list in order of merit and performance in viva-voce and prepare a panel of the Commissioners which shall be valid for a period of 3(three) years.

Final selection shall be subject to overall suitability.
