**O R D E R No - 142/2023**

Placed before me Letter no. 019/HCIICC dated 06.11.2023, of Hon'ble High Court of Jharkhand Ranchi. Hon'ble High Court has been pleased to direct to constitute the 'Internal Complaints Committee' (ICC) in regard to ensure proper compliance of "Sexual Harassment of Women at Workplace( Prevention, Prohibition and Redressal)" Act 2013, i.e POSH Act.

Further, Hon'ble High Court has been pleased to direct that at least two Judicial Officers (Preferably women but in case of women Judicial Officer(s) are not available, then any Judicial Officer) be made members of the ICC with the chairperson of the ICC, invariably being Judicial officer.

Perused the report of Judge-in-Charge and Head Clerk. Judge-in-Charge in his report has submitted that a Complaint Committee related to 'The Gender Sensitization and Sexual Harassment of Women at Workplace( Prevention, Prohibition and Redressal) Act 2013 was re-constituted vide Order No 124 dated 30<sup>th</sup> day of November 2021 of the then Learned Principal District & Sessions Judge Simdega with Chairperson, Mrs Lata Tirkey, a social worker with seven other members, but no Judicial Officer has been made Member of this Committee. And this Complaint Committee is still functioning.

Accordingly, in compliance with above mentioned direction of Hon'ble High Court, present 'Complaint Committee' reconstituted vide this office Order no. 124 dated 30.11.2023, is being discontinued.

A Fresh 'Internal Complaint Committee' in accordance with above mentioned direction of Hon'ble High Court is being Constituted.
