Terms and Conditions:

1. The candidates must be an Indian citizen as defined in Article 5 to 8 of the Constitution of India.
2. The candidates must not be less than 18 years and more than 38 years of age as on 01.01.2020. The Upper age will be relaxable as per norms, Govt. of Assam.
3. Minimum Qualification is Class VIII pass and candidates must have valid Driving License for LMV.
4. If any candidate is found to have suppressed his educational qualification or given any wrong information at the time of applying for the post, his candidature shall be liable to be rejected.
5. The applicant must clearly mention on the envelope the name of the post applied for.
6. The last date of receipt of application is 21.01.2020 at 4.30 p.m. *21.12.2020*
7. Candidates serving in Govt. department must apply through proper channel.
